

**CITY AND COUNTY OF BROOMFIELD  
NOVEMBER 1, 2011 GENERAL ELECTION  
UNOFFICIAL RESULTS**

This report contains the unofficial results of all ballots received and counted by 7:00 p.m. November 1, 2011.

There are three categories of pending ballots that are eligible to be added to the unofficial results:

1. provisional ballots;
2. Uniformed and Overseas Citizen Absentee Voters (UOCAVA); and
3. mail ballot signature deficiencies.

1. Provisional ballots are ballots issued to voters whose eligibility to vote in this election cannot be readily verified by election workers. By law, the Elections Division has up to 14 days following the election to complete verification. Once verified, these ballots will be added to the official results.

**There are 0 provisional ballots to be verified.**

2. UOCAVA ballots may be received in the Elections Division up to eight days following the election. If received, they will be added to the official results.

**There are 35 outstanding UOCAVA ballots.**

3. Mail ballot signature deficiencies are ballots that were received by the Elections Division either unsigned by the voter, or the election judges determined that the signature on the affidavit does not match the signature on the voter registration records. In both cases, elections staff notifies the voter of the discrepancy by mail. The voter has up to eight days following the election to reconcile the signature. If reconciled these ballots are added to the official results.

**There are 89 outstanding signature discrepancies.**

The total number of outstanding ballots from all three categories that MAY be added to the official results is 124.

Once all eligible ballots have been tabulated and the canvass of election has been completed, OFFICAL RESULTS will be released.
